



## LIABILITY RELEASE & WAIVER FOR MINORS

**Permission to Participate:** As the parent or legal guardian, I hereby grant permission for my child to participate in the GrowNYC Governors Island Educational Program. The program requires transportation to Governors Island by ferry and includes interactive lessons, including but not limited to, gardening demonstrations, farmed food sampling, and a walking tour of the premises (the Activities). I acknowledge and agree that my child and I must wear a face covering at all times while participating in the Activities and agree to practice social distancing as practical; appreciating the risks involved, I agree to the following:

**Release and Waiver:** I hereby release and forever discharge and hold harmless The Council on the Environment, Inc. d/b/a GrowNYC ("GrowNYC"), a non-profit corporation, including successors, assigns, officers, directors and employees from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from any harm to my child suffered during or as a result of his/her visit to Governors Island and related Activities. I understand that this Release discharges GrowNYC from any liability or claim that I or my child may have with respect to any injury, illness, death, or property damage that may result from the visit to Governors Island and participation in related Activities, whether caused by the negligence of GrowNYC, its officers, directors, employees, or agents or otherwise.

**Medical Treatment:** I hereby release and forever discharge GrowNYC from any claim which arises on account of any first aid, treatment, or service rendered to me or my child in connection with any incident at Governors Island.

**Indemnity:** I will indemnify and hold harmless GrowNYC for any damage caused or liability incurred by my child during his/her visit to Governors Island.

**Photographic Release:** GrowNYC may photograph me and my child during the visit. I understand that my own and my child's photograph may be taken during his/her visit to Governors Island and hereby allow GrowNYC staff or media organizations to take photographs, videos and/or audio recordings, which contain images of me and/or my child. I understand that these images may be used by GrowNYC or their respective supporters, and agree to allow them to publish or reproduce such images. I grant GrowNYC all rights, title, and interest in any images taken by GrowNYC of me and my child during the visit to Governors Island.

**Other:** I expressly understand that this Release is intended to be as broad and inclusive as permitted by the laws of the State of New York that this Release shall be governed by and interpreted in accordance with the laws of the State of New York. I agree that in the event that any provision of this Release shall be held to be invalid by any court, the invalidity of such provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
